

## Forewords

The South Metropolitan Health Service (SMHS) Research Report describes the research activity in the Fiona Stanley Fremantle Hospital Group (FSFHG) and Rockingham Peel Group (RkPG), in the 2017 calendar year.

The list of research projects for 2017 was collated by:

- Assessing which of the reported 2015-2016 projects were ongoing
- Auditing the online Research Governance Service for new projects commenced in 2017
- Circulating the project list to Heads of Department, Heads of Service and clinical trials staff to check for completeness.

The list of publications and other research activity was collated by:

- SMHS/EMHS library staff performing detailed searches on key investigators for 2017 publications
- Submissions provided by investigators on an agreed template (Appendix A).

### From the SMHS Chief Executive

This report highlights the large volume of research activity conducted across SMHS during 2017. It also demonstrates the high level of dedication of our staff in communicating and translating their research through publication. This is something of which we should all be proud.

The past year has seen significant changes to the research environment with the ongoing implementation of the online Research Governance Service (RGS), which changed the process of research submission and review across WA Health. I would like to thank staff for their dedication to supporting the implementation of this system and the additional training and learning undertaken to facilitate its capability. In the future, the system will provide critical information about research activity within SMHS and WA Health more broadly.

In 2017 we also saw the introduction of the National Mutual Acceptance (NMA) Scheme which aims to make it easier for WA sites to be included in national research projects without having to undergo additional ethical and scientific review. We are already starting to see a large number of projects coming to SMHS through this scheme.

There is a large diversity of research conducted within SMHS with projects including sponsored clinical drug trials, national collaborative trials as well as a range of locally initiated projects aiming to improve patient outcomes.

Research is critical to SMHS and the community it serves. It is a credit to our investigators that this research impacts beyond the local setting with the outcomes of these projects often having national and international significance.

## **Executive summary**

The South Metropolitan Health Service (SMHS) Board has outlined research as a key enabler to deliver on its strategic priority of *Excellence in the delivery of safe, high quality clinical care.*<sup>1</sup>

It is also recognised that research is a pivotal enabler of the other four strategic priorities of SMHS:

- Provide a great patient experience
- Engage, develop and provide opportunities for our workforce
- Strengthen relationships with our community and partners
- Achieve a productive and innovative organisation which is financially sustainable.

The attraction and retention of credible researchers is extremely important to SMHS, as "research is fundamental to achieve excellence in care and improve patient and consumer outcomes".<sup>2</sup>

In 2017, the majority of research in SMHS has been conducted at Fiona Stanley Hospital (FSH). However, a significant number of projects involve collaboration across SMHS sites including Fremantle Hospital and Rockingham General Hospital (RGH).

This report showcases research activity in FSFHG and RkPG and is a testament to the passion of our researchers and is worthy of celebration. SMHS has recently developed an operational plan for research which will provide the direction for research in SMHS over the next three years. This report aims to capture all research activity during a calendar year. It is important to note that many projects take place across a number of years and as such will appear in multiple annual reports. A number of the projects being conducted in 2017, and captured in this report, have been carried over from the 2015–2016 report. As such, the number of projects reported represents total research activity, rather than the number of new projects.

In 2017, FSFHG was involved in **320** projects, which is an increase from the 2015 and 2016 SMHS Research Report<sup>3</sup>. This increase in projects was consistent across all services. The research activity at RkPG was consistent with the 2015–2016 report with **16** trials being conducted in 2017.

In addition to the large number of projects being conducted, there were **347** publications produced in 2017, which is an increase compared to the previous two years (353 across both 2015 and 2016). These publications often involve collaboration across departments and services. For this report, these publications have been recorded once under a single department. Due to the methods used to collate the publications it is likely that some will have been missed if investigators have not self-reported. In addition, some researchers may have published under affiliations other than SMHS i.e. their respective universities.

8 FSFHG Service Five projects 20 FSFHG other service projects There were **92** ethics approvals granted in 2017 by the SMHS Human Research Ethics Committee (HREC). This is a decrease in the number of approvals from previous years, according to the 2015–2016 report (205 approvals in 2016 alone). This reduction in activity can be attributed to the separation of the Royal Perth Hospital HREC from SMHS, with the establishment of East Metropolitan Health Service (EMHS).

There were **155** site authorisations processed by the SMHS governance team in 2017. This also represents a decrease from **211** in 2016. However, this can also be largely attributed to the separation of Royal Perth Hospital authorisations from SMHS.

## **Research environment**

During the past few years, the research environment within SMHS has experienced several large scale changes, and some exciting new developments to enable research activities and empower researchers:

- Research Governance Service (RGS) 2016: RGS is the WA Health Information Technology platform that manages all Ethics and Governance submissions and approvals across WA Health. Implementation of this system enabled WA Health to qualify for the National Mutual Acceptance Scheme in 2017.
- National Mutual Acceptance (NMA) Scheme 2017: Introduced in mid-2017 this process allows the HREC approval granted by a Lead HREC to be applicable across Australia (excluding the Northern Territory). This reduces duplication and promotes the inclusion of Western Australian sites in projects being led by other jurisdictions.
- Low risk fast track 2017: In late 2017 a low risk fast track process was trialled in an effort to reduce the time to approval for low risk research. The trial was a success and new processes have been implemented to review low risk projects through an expedited process.
  - During the trial 25 projects were reviewed which resulted in 17 site authorisations and 5 ethics approvals. Only two studies received both ethics approval and site authorisation and 5 projects were still under review at the completion of the trial period but later received approval.
  - Average time for ethics approval during the trial was 14 days.
  - Average time for site authorisation during the trial was 4 days, with 50% completed in 2 days or less.
  - Site authorisations were signed off by the Manager of the Research Ethics and Governance Unit.
  - A number of recommendations were made at the conclusion of the trial. These are currently being implemented.

Pr	oject title	Brief description
1.	Hypoglycaemia in adults with diabetes: Inpatient incidence and prevention using novel sensing technology.	A waiver was granted to conduct an audit of the incidence of inpatient hypoglycaemic events together with their relationship to co-morbidities, therapies for diabetes and non-diabetic illness, and length of stay. This information supported the second phase of the study.
2.	Predictors of anastomotic dehiscence, a comparison of C-reactive protein, procalcitonin and neutrophil to lymphocyte ratio.	A waiver was granted to conduct an audit of normal practice regarding inflammatory markers, C-reactive protein, procalcitonin and neutrophil to lymphocyte ratio following colonic and rectal anastomosis. The aim is to discover if any of these markers have any value in predicting anastomotic leak following anastomosis.
3.	C-Reactive protein as a predictor of the severity of CT findings in acute diverticulitis.	A waiver was granted to conduct an audit of the inflammatory biomarkers c-reactive protein and white cell count in patients that presented acutely with acute diverticulitis who also underwent CT scanning as part of their initial investigations. The aim is to discern if it is possible to predict the severity of diverticulitis based on their initial inflammatory marker levels.
4.	WA Neck of Femur Fracture Collaboration.	A waiver was granted to conduct an audit of patients presenting with a fractured neck of femur. The aim is to better describe and share (publish) interventions and outcomes instituted within an evolving standard of care of these patients within the hospitals involved in the project.
5.	Optimising vancomycin dose using Bayesian forecasting: A retrospective audit with a prospective evaluation of informed predictive dosing.	A waiver was granted to conduct a review of the current practice of vancomycin dosing for inpatients receiving intermittent intravenous bolus dosing. These will be assessed against the explicit standards which are set out in National Guidelines (1), specifically, target through vancomycin concentrations.

6.	Biomechanical modelling of type B aortic dissection.	A waiver was granted to allow access to de- identified CT scans to investigate a new method (computational fluid dynamics) to see if treatment outcomes can be predicted for those with Type B aortic dissection.
7.	Pre-treatment wait time for head and neck cancer in Western Australia.	A waiver was granted to conduct an audit on pre- treatment wait times for Head and Neck Cancer (HNC) patients. The aim is to the predictive factors for increased wait time, and determination of the effect of increasing wait time on tumour volume and staging.
8.	The identification of national heritage, ethnicity and/or religion in clinical handover or medical records at a large teaching hospital.	A waiver was granted to conduct an audit of patient records with the aim of establishing if the frequency and rationale for a patient's national heritage / country-of-birth, ethnicity or religion is mentioned or recorded, either during clinical handover in the intensive care unit, or in the written electronic medical records of a large, metropolitan, teaching hospital in Perth.
9.	Post-operative feeding of colorectal surgery patients at Fiona Stanley Hospital and its impact on outcomes.	A waiver was granted to conduct an audit to quantify post-operative feeding practices at FSH in colorectal patients undergoing elective surgery. This information will then be compared to the evidenced based Enhanced Recovery After Surgery (ERAS) principles and recommendations for improvements to current practices made.
10.	Oesophageal cancer and impact of dietetic involvement during combined chemotherapy and radiotherapy treatment.	A waiver was granted to conduct an audit of medical records to determine if dietetic intervention is beneficial to patients with oesophageal cancer undergoing combined chemotherapy and radiotherapy.
11.	Retrospective analysis of clinical efficacy and outcomes of left atrial appendage device occlusion in patients with atrial fibrillation.	A waiver was granted to conduct an audit of the medical records of patients who have undergone insertion of Left Atrial Appendage Occlusion device (LAAO). The aim is to look at clinical outcomes in regards to efficacy of the device in reducing risk of stroke as well as secondary outcomes and complications.

12.	Endoscopist prediction of colonoscopy findings from pre-procedure data. Is endoscopy "like a box of chocolates" where you don't know what you are going to find?	A waiver of consent was granted in order to facilitate an analysis of the predictive value of the referral documentation for specific colonoscopy findings and to determine the additional value of the endoscopist interview of the patient for predicting colonoscopy findings. Patient data was required to effectively analyse the result of endoscopist interview data.
13.	Evaluation of IVD Becton Dickinson Barricor Venous Plasma Collection Tube.	A waiver was granted to allow the collection of an additional 3ml of blood from patients undergoing routine blood tests. The aim is to evaluate the suitability of a new collection tube.
14.	Audit investigating Prevena (R) incision management system and its effects on wound healing and infection rates when used on abdominal wall hernia repair.	A waiver of consent was granted to conduct an audit of medical records to determine if the new management system has been effective in reducing surgical site infection and is cost effective.
15.	Prophylactic enteral feeding vs. oral diet or reactive tube feeding in patients with head and neck cancer undergoing curative radiotherapy +/- chemotherapy treatment at Fiona Stanley Hospital (FSH)	A waiver of consent was granted to conduct an audit on how many patients receive prophylactic tube placement at FSH prior to curative radiotherapy +/- chemotherapy. Collecting this data will assess the impact on weight and unplanned admissions for those that either receive a prophylactic feeding tube versus those that have either oral diet only or a reactive feeding tube placed. This will also allow a comparison to current guidelines.
16.	Previous Hospital Presentations for Inpatient Alcoholic Liver Deaths: A Multi-tertiary Centre Project.	A waiver was granted to conduct an audit of medical records of patients who have died from alcoholic liver disease. By determining previous hospital presentations it will increase physician knowledge of opportunities for intervention for patients with alcoholic liver disease. As such creating the potential for prevention of disease progression and reducing morbidity, mortality and health care resource utilisation.
17.	Factors contributing to early postoperative endoscopic recurrence in Crohn's disease.	A waiver of consent was granted to conduct an audit of medical records for patients who had a small bowel or ileo-colic resection between 2012 – 2016 and had a post-operative surveillance colonoscopy within the first 12 months of surgery. These results will be used to inform local practice.

18.	Correlation between site of stroke lesion and pushing behaviour.	A waiver of consent was granted to conduct an audit of medical records of stroke patients to describe the relationship between site of stroke lesion and pushing behaviour.
19.	Surgical Pleth Index as a predictive tool for postoperative pain: validation of a cut-off value and investigation of the influence of age.	A waiver of consent was granted to prospectively validate the surgical pleth index (SPI) cut-off published by in a larger cohort. In addition, to evaluate the influence of age on the SPI cut-off value predicting moderate-severe pain, as well as the influence of a different anaesthetic technique (total intravenous anaesthesia) on the predictive value of SPI.
20.	Fungal surveillance in Western Australia.	A waiver of consent was granted to examine over time the trends of fungal infection in Western Australia.
21.	Assessment of the long term effects of the Hyperbaric environment on the Pulmonary function of Chamber attendants at a tertiary hospital hyperbaric medicine unit.	A waiver of consent was granted to conduct a review of Hyperbaric chamber attendants' lung function records to assess changes in lung function over time. This information may influence long term occupational safety guidelines.
22.	Combining demographic, treatment and laboratory information with population pharmacokinetic modelling to select the best doses of clozapine for patients with difficult-to-treat psychoses.	A waiver of consent was granted to create a population model from 750 patients that incorporates the effects of dose, time from dose, age and gender on concentration variability for clozapine and norclozapine, to estimate the effects of these treatment and demographic characteristics.
23.	Evolution of beta-lactam resistance in Pseudomonas aeruginosa during treatment of major burn injury.	A waiver of consent was granted to allow collation of minimal clinical data to record extent of injury expressed as total body surface area and antibiotic administration history. This information is to be used in the analysis of Pseudomonas aeruginosa isolates for antibiotic resistance.
24.	Defining and Defeating Aboriginal and Torres Strait Islander Disadvantage In Breast Cancer Survival.	A waiver of consent was granted to access medical records for Aboriginal and Torres Strait Islander breast cancer patients. This project also required approval from WAAHEC and WA Health HREC. The aim is to explore the full range of biological drivers that could fuel adverse Aboriginal and Torres Strait Islander outcomes.

25.	A radiographic study of the location of bifurcation of the superficial temporal artery – Is there a sound anatomical basis for the Gillies approach in temporal artery biopsy?	A waiver of consent was granted to conduct an audit of CT angiograms of the head and neck to quantify the location in millimetres of the bifurcation of the superficial temporal artery to the root of the zygomatic arch and the root of the helix based on the 3D reconstruction image of each CT angiogram. The aim is to fill gaps in knowledge and may lead to the use of a new technique to biopsy the STA that purports to facilitate diagnosis and reduce morbidity associated with giant cell arteritis.
26.	Is highly-sensitive troponin testing advancing clinical practice, improving outcomes and cost-effective in the investigation and management of chest pain in the Emergency Department?	A waiver of consent was granted to utilise patient records to evaluate the treatment, management, cost and outcome at 1 year before and after the introduction of new blood tests in a national multi- hospital study.
27.	Identification of EMAST- positive tumours.	A waiver of consent was granted to use formalin- fixed paraffin-embedded (FFPE) colorectal cancer specimens to optimise local protocols for analysis of these samples.
28.	Vitamins and delirium in older ED patients.	A waiver of consent was granted to conduct an audit of clinical records to compare vitamin B1 and D levels in people with and without delirium presenting to the Emergency Department (ED). The aim is to identify the relationship between vitamin deficiency and delirium which could allow for the planning of interventional trials for delirium treatment.
29.	Pilonidal Sinus Disease: Western Australia Metropolitan Health Services – Definitive Surgical Practice Preferences, Outcomes and Patient Perspective.	A waiver of consent was granted to conduct an audit of clinical records to assess the current surgical management for pilonidal sinus disease in the Western Australian (WA); Metropolitan Health Services (MHS). This data forms part of a study aimed to also assess surgical and patient perspective on current surgical management.
30.	The Australian Motor Neuron Disease Registry.	Opt-out consent was granted for inclusion of motor neuron disease patients in a national registry.

# Heart patients taking part in exercise study

While exercise has been shown to be good for you when you have coronary heart disease, researchers at Fiona Stanley hospital (FSH) want to find out which form of exercise is best for these patients.

FSH Head of Exercise Physiology and principal investigator, Andrew Maiorana, said they want to find the most effective ways to engage coronary patients in exercise.

"Exercise is really good for heart disease. If we can determine the best way to maintain good overall health and fitness, then we can encourage our cardiac patients to get moving," Andrew said.

"We are comparing pool-based exercise, gym exercise and participants continuing their usual activity to compare the effects on fitness, strength, body composition, artery health, blood test results and brain blood flow," he said.

Andrew said the study is recruiting patients over 18 years of age who have had a cardiac episode at least six months ago.

"We are recruiting people who have been diagnosed with coronary heart disease, with a previous heart attack, stent or coronary artery bypass graft surgery, who are willing to commit to a 12 week program," he said.

77 year old former patient, Herbert Auchli, joined the study following a heart scare almost three years ago.

"I thought I had really bad indigestion. After a trip to the health clinic and an ambulance to FSH, I ended up having three stents inserted into a blocked artery," he said.

Herbert has always been interested in research, so he jumped at the opportunity and encourages others to do the same.

"Research is an important part of our society. I am doing something for the community by doing something for myself and am really enjoying the program so far," he said.

The study is in collaboration with FSH, Curtin University, The University of Western Australia and Royal Perth Hospital and is funded by the National Heart Foundation and the Spinnaker Foundation.



## Landmark study to detect lung cancer early

Fiona Stanley Hospital (FSH) is taking part in an international lung cancer screening study to determine the most effective methods for early lung cancer diagnosis.

Lead Investigator and FSH Respiratory Physician Dr Annette McWilliams said lung cancer was the leading cause of cancer deaths in Australia.

"A lot of work has been done in lung cancer screening in past 15 years to get to this point, we are now part of a landmark study," Dr McWilliams said.

"The use of low dose chest CT scans has been shown to save lives from lung cancer but we do not yet have a lung cancer screening program in Australia."

The study is recruiting participants aged between 55 to 80 years of age who are current or former smokers to undertake a risk assessment, breathing test and, if eligible, a low-dose chest CT scan and then tracked for five years.

Patients with suspicious lesions are seen in the FSH Fast Track Lung Cancer Clinic for management, diagnosis and treatment, and continue as part of the study.

Dr McWilliams hopes this trial is the catalyst for change in how lung cancer is diagnosed in Australia to lead to better survival outcomes.

"Currently, the survival rates for lung cancer are only 15 per cent, as most patients have advanced, incurable disease at the time of diagnosis," Dr McWilliams said.

"Smoking cessation remains crucial but about 60 per cent of lung cancers in Australia occur in people who have already quit smoking or have never smoked.

"Lung cancer screening with low dose chest CT has been proven to reduce lung cancer deaths and save lives."

Several countries including the USA and Japan have either implemented lung cancer screening or are evaluating implementation methods. This study, also underway in Canada and Hong Kong, will provide crucial information for implementation of lung cancer screening in Australia in partnership with Cancer Council NSW.





Western Australian pre-exposure prophylaxis for HIV implementation trial.

Dr Lewis Marshall



Reducing the number of HIV presentations by providing access to vital medication is Sexual Health Physician Dr Lewis Marshall's aim in a state-wide implementation research study.

Dr Marshall is part-way through the study which has focused on creating strategies and disseminating a co-formulated pill of the medications Tenofovir and Emtricitabine.

"We know the medication works. We just need to get the logistics right and get men who have sex with other men onto the medication," Dr Marshall said.

"We ask suitable participants to take the medication once daily and then present for follow up every three months, this has been shown to reduce the risk of contracting HIV by more than 90 per cent."

Dr Marshall said early indicators showed the strategy has been successful with a drop in HIV presentations.

## "From what we can see so far, HIV rates in WA have dropped from 88 new cases in 2016 to 68 in 2017," he said.

"There is still no cure for HIV but there is very effective treatment to manage the condition and this is really having an effect on the community."

The study is also looking at the impact of this medication on the rates of gonorrhoea, syphilis and chlamydia.

"By reducing the risk of contracting HIV, we need to determine the effect of increased sexually transmitted infections and anecdotally we are seeing a surge," Dr Marshall said.

"In having participants monitored every three months, we hope to catch any infections early, to treat them and reduce the spread of infection amongst the community."

To date, Dr Marshall and his team at Fremantle Hospital's South Terrace Clinic have recruited 90 patients to the study, with the hope of getting to150 by the time recruitment finishes in September.

Dr Marshall said he was passionate about undertaking research as maintaining best practice was crucial in providing the best patient care.

"Research is a critical function and must instruct everything we do to ensure we are continuously improving patient outcomes," he said. When the trial ends in April 2019, the drug will be available through the Pharmaceutical Benefits Scheme (PBS) and patients will still be encouraged to attend sexual health clinics for three monthly monitoring.

The study was initiated by the Department of Communicable Diseases control branch and has been coordinated by the Kirby Institute.

## Research focus on patient outcomes

Undertaking research to ensure better patient outcomes is what drives Fiona Stanley Hospital (FSH) Anaesthetist Dr Ed O'Loughlin.

Dr O'Loughlin, who has has seven anaesthesia-related studies underway, said the style of perioperative research had changed over the years.

"Our focus in research has shifted over the past few years as we place more of an emphasis on what we can do to make a patient's health outcomes better not only now, but in the weeks, months and years following their stay in hospital," he said.

Under Dr O'Loughlin's leadership as a principal investigator at FSH and on the National Health and Medical Research Council, the hospital is participating in a global, \$4.6 million, 8880 participant trial called PADDI.

"We are looking at the effect of a very commonly used anti-nausea medication, Dexamethasone, and whether or not it contributes to patients getting infections after their surgery," Dr O'Loughlin said.

"Half of the patients are being given this medication post-surgery to decrease swelling and make them feel better, but we don't know if it is increasing the rates of infection, resulting in poorer outcomes.

"This study is a prime example of our change in research focus. A medication might make a patient feel better in the first 24 hours but make them worse a month to six months later."

The impact of the work of the anaesthesia and pain research team can be felt not only by the individual patient, but also their family, the community and health service.

"We, the whole research team, focus on those things that matter to patients, which include getting them back home and moving, as well as reducing delirium and complications," Dr O'Loughlin said.

"Research is critically important for us to know whether our interventions are making a difference in the lives of patients.

"I am forever curious and enjoy challenging the status quo to find the best results for our patients."





## Listening to patients to improve outcomes

Giving patients a voice and learning from their experiences is at the core of the latest research project by Senior Physiotherapist Dale Edgar.

This study is exploring the patient journey to see how the system and clinicians can work to decrease the risk of complications and deliver better outcomes after general surgery.

"By speaking with our patients and understanding where the shortfalls are, it will assist with informing on potential interventions," Dale said.

"We hope by adding exercise intervention (prehabilitation), it will give us time with patients to not only do a work up in the gym, but provide tailored education and manage expectations."


Dale has been a senior researcher and allied health professional in the State Adult Burns Unit for almost 20 years. He has published more than 80 articles and been involved in more than 100 research projects. Dale is using this experience to cross-pollinate and assist in making change across different specialities.

"I hope to take my learnings and understanding from my work in burns and propagate this across other areas," Dale said.

"Similar work has also been completed in cardiovascular and upper abdominal surgery. Pulling all of the knowledge from these fields together to make change in general surgery should have a significant impact.

"While there may be different risk profiles and areas of risk in each speciality, the one constant is that patients require a general anaesthetic which increases the risk of respiratory and circulatory complications.





"The assumption is that if we can reduce the risks of patients having an anaesthetic by assisting them to be fitter and stronger for surgery we hope to mitigate complications and improve overall outcomes."

The study has commenced recruitment to four focus groups, a mix of pre and post-operative patients.

Senior Physiotherapist Dale Edgar with patient Josh Brock.

Dale believes this interaction with patients will improve all aspects of their experience, make the patient journey as efficient as possible and give them the best chance of a good outcome.

"Understanding the power of the patient's voice is crucial for us to improve the patient journey and their quality of life after the experience," Dale said.

# Understanding determinants of health

Understanding how health literacy impacts people with type 1 diabetes in managing their condition is part of a study being undertaken at the Fiona Stanley Hospital Diabetes Clinic by The University of Western Australia PhD student and Nurse Practitioner Jennifer Nicholas.

By looking at health literacy data, Jennifer's project aims to inform strategies which can be used to mitigate risk factors contributing to poorer diabetes health outcomes.

"The management of diabetes is complex and very unique to each person living with the condition," Jennifer said.

"We want to understand the relationship between health literacy, diabetes knowledge, contextual factors, psychological distress and coping styles, and how these may influence diabetes-related health outcomes.

"Healthcare professionals need to understand how to clearly identify individual barriers and then plan individual care accordingly. Understanding and having access to health information may be one of these barriers for patients."

The Australian Commission on Safety and Quality in Healthcare has identified that approximately 60 per cent of Australians have less than adequate health literacy.

"There is little Australian data showing the association between health literacy, knowledge and psychological factors associated with the burdens that can influence health outcomes for adults with type 1 diabetes," Jennifer said.


"This study aims to fill a gap in knowledge and provide data to guide our health care practices, with the aim of more targeted and personalised diabetes self-management education to every individual."

The study aims to recruit 100 participants.

# Learning to thrive after a patient survives

Understanding the effect of surviving a stint in an intensive care unit (ICU) is the premise of a new study by Rockingham General Hospital ICU Consultant Dr Ravikiran Sonawane.

Dr Sonawane said the number of patients leaving ICU alive has increased steadily over the years.

"Survival rates in ICUs have been improving with enhanced care. Our focus is now shifting to not only improving survival but also quality of life, so patients can resume their baseline quality of life again after a significant stay in hospital," he said.

"When patients leave ICU we are finding they have what we call 'post-intensive care syndrome' (PICS), where they suffer from physical weakness and mental affliction.

"These symptoms are serious and can last months and, in some cases, the rest of their lives.

"The effect of weakness has a huge impact on their day to day functioning and overall lifestyle. In addition to this, people can experience increased anxiety, nightmares, partial recollection and post-traumatic stress disorder symptoms which can be difficult to overcome without support.

"In the older population we are finding these after effects can sometimes change patient's treatment decisions."

The study will survey 100 patients throughout their first year of discharge from the ICU, at six and 12 month intervals, to analyse their emotional wellbeing and the community resources they may be using to aid their recovery.

Dr Sonawane hopes the study will help raise issues to shape the future of ICU services and allow for ICUs to offer follow up outpatient clinics.

"If we can extend the scope of an ICU beyond survival and into discharge we hope to assist patients in achieving a holistic recovery," he said.

"By doing this research we can improve our practices and give patients the best chance at life."


